1. **BIDDERS** WILL BE IDENTIFIED BY NUMBER RATHER THAN BY NAME. **AUCTIONEER** WILL RECORD ALL SALES UNDER YOUR REGISTRATION NUMBER ONLY. THE COST OF THE BIDDER CARD IS \$210 WHICH \$200 IS REFUNDABLE IF THERE IS NO PURCHASE. IF A PURCHASE IS MADE THE \$200 WILL BE APPLIED TO THE TOTAL.
2. **FEE 'S THAT WILL APPLY TO EACH VEHICLE: 10% BUYERS PREMIUM \$55.00 PREPARATION FEE, AND TAX (% DEPENDS ON COUNTY WHERE YOU RESIDE. A TRANSACTION FEE OF \$25.00 WILL BE CHARGED WITH CREDIT CARD PAYMENTS. THIS CHARGE WILL BE WAIVED WITH CASH PAYMENT. \$58.00 SMOG FEE, LICENSE & REGISTRATION FEES (IF APPLICABLE) WILL BE ADDED TO THE SALE PRICE AND WILL BE COLLECTED HERE. CUSTOMER DEMANDING CERTIFICATE OF TITLE WILL BE EXEMPT TO PAY FOR LICENSE & REGISTRATION FEES ONLY. IF THE VEHICLE IS NOT CURRENTLY REGISTERED, THEN BUYER MUST PURCHASE A ONE WAY TRIP PERMIT.**

BUYER AGREES TO INDEMNIFY AND HOLD HARMLESS THE SELLER AND AUCTION FROM ALL DAMAGES, CLAIMS, AND LIABILITIES FROM INJURIES TO PERSONS OR PROPERTY OF ANY KIND WHATSOEVER HERE ON PREMISES, AND WHEN ATTENDING OUR AUCTION OR REMOVAL OF PURCHASES. SOME VEHICLES DO NOT HAVE KEYS.
